Rynda is an international real estate investment management firm. Rynda is committed to protecting and respecting your privacy. This notice describes how we will collect and use your information and the rights you have in relation to your information.

We may collect information from you about your preferences through your use of this website, when you request information from us or engage with our services, or as a result of your relationship with one or more of our clients.

INFORMATION WE COLLECT

Rynda may ask for and collect from you personally identifiable and other information at certain points via this website. In addition to the information you knowingly provide, Rynda collects the domain names and IP addresses of its visitors, along with usage statistics (e.g., types of web browsers and operating systems used) and browsing history. This data is used to promote our services. Rynda may combine this information with the personally identifiable and other information it collects.

Rynda does not collect personally identifiable information about your online activities over time and across third party websites or online services. Our third-party suppliers do not collect personally identifiable information about your online activities over time and across third party websites or online services through your use of this website.
